

## Boots to Books & Beyond Campaign

During the next decade, more than one million veterans will be returning from military service in Afghanistan and Iraq. Many of those returning will live in Grayson County, due to its proximity to veteran resources and regional employment opportunities as well as its lower cost of living compared to the neighboring DFW Metroplex.

Veterans come home and face a whole new set of challenges, including restoring their physical and mental health; finding employment; and navigating the complex network of benefits, services, and support (including educational) that is available to veterans. Increasingly, they are turning to community colleges to prepare for new careers and learn how to transfer military skills to the workplace. This growing student population has unique needs for which many colleges are underprepared.

The Grayson College Foundation has launched a campaign to support student veterans at Grayson College. The Boots to Books and Beyond Campaign funds will support critical on-campus resources, services, and activities during the next five years of troop draw downs — and beyond.

## Better Serving Those Who Have Served

The Boots to Books and Beyond Campaign will raise funds to provide and maintain on-campus support services to meet the distinct needs of student veterans including:

- A centralized veterans center for access to specialized services, where veterans can connect with each other, study and relax
- Counseling and disability services to assist those with both physical and emotional injuries
- Emergency, "gap," and scholarship funding to ensure student veterans are not forced to drop out due to a lack of veteran benefits or unexpected expenses
- Veterans benefits advisers with expertise in military transcripts and translating credit for prior learning,
- Coordination of services for veterans and their families, and
- Peer mentoring and case management services that provide emotional and academic support from those with similar experiences.
