New Annually-Funded Scholarship - *SCHOLARSHIP NAME: _____
 *To establish your own personally-named (annual) scholarship, a minimum contribution of ***\$250.00 per/year** is required – this may be done through monthly payroll deductions or with a one-time gift; sponsored scholarships may be designated to specific academic program areas; recipients will be selected by the GC Foundation Scholarship Committee and should meet the following minimum criteria: be enrolled in 6+ credit hours per semester, and hold/maintain a 2.5+ GPA. *Annual student awards typically range from \$250-\$1,600 and may be used by the recipient for payment of tuition, fees, textbooks and classroom supplies purchased in the Campus Bookstore.

New Endowed Scholarship - SCHOLARSHIP NAME: _____
