

High School Career Ready Pathway

CCMA-Phlebotomy

SUMMARY

Completing these two credentials enables students to enter the workplace and fast-track their career in Health care. Upon successful completion students should be prepared for employment as a Clinical Medical Assistant and/or Phlebotomist. Both are excellent preparation for working a long term career in Healthcare. Completion also earns them one point toward the program entrance selection to the competitive Grayson College Vocational Nursing Program.

CURRICULUM

The hybrid curriculum is provided by Grayson College and consists of materials located in the Canvas Learning Management System and is complemented by hands-on lab activities on a Grayson College Campus (Main).

PROGRAM REQUIREMENTS

Students must be 16 years old by the start of clinicals. Students must successfully pass a drug test which will be administered at a mandatory orientation the first day of class. Drug tests may be repeated throughout the program. Failure of a drug test will make the student not eligible for the program.

The following immunizations are required and must be fully completed and Submitted to SURSCAN PRIOR TO THE FIRST DAY OF CLASS. Information about this process will be sent to the student via their counselors.

- Varicella (Chicken Pox), Proof of either:
 - o two documented doses of varicella immunization
 - or a titer test (blood test) confirming immunity

- Hepatitis B series, Proof of either:
 - o a complete three-injection series of Hepatitis B vaccinations,
 - o a complete two-injection series of Heplislav
 - o a titer test confirming immunity (positive reading)
- MMR series, Proof of either:
 - o a complete two-injection series of MMR vaccinations, or
 - o a titer test confirming immunity (positive reading)
- Tetanus/Diptheria/Pertussis (TDAP) (within past 10 years)
 - o DTAP or TD not acceptable
- Meningococcal Vaccine proof of either:
 - one dose of the vaccine within 5 years and at least 10 days prior to the first day of class, or
- Influenza Vaccine (the most recent variation)
- TB Exam: Obtain proof of a negative TB (tuberculosis) test. Blood or skin test must be within one year, negative chest x-rays must be within five years.
- COVID Vaccine
 - Grayson College does not require this vaccine, however, clinical agencies do. Medical and religious waivers are considered, and requirements are subject to change at any time. We understand that it is your choice to receive the COVID vaccine; if you choose not to attend your clinical education placement due to a vaccine requirement, we will try to accommodate your request. However, we cannot guarantee you an alternate placement, which may impact your program completion.

Students should have reliable transportation to and from campus and the clinical sites

SCHEDULE

Students complete online coursework, hands-on lab skills practice and clinical hours in healthcare settings. Students will register for their mandatory in class sessions and clinical practicums, which will take place in various facilities in Grayson County.

- Monday-Thursday, 1-3pm (Attendance on campus is required for class sessions)
- August 14, 15, Orientation and drug testing, (allowing time for schedule changes if necessary no program content)
- August 19th- December 6th Fall classes
- January 13th- May 9th Spring classes

ATTENDANCE

Students who miss more than 15% of total program hours are ineligible for program completion and will receive a failing grade. The only exception being school sponsored events. Students can not have more than one clinical absence. In person sessions will be offered at Grayson College Main Campus, Health Sciences building.
